DON MITCHELL is Professor and Chair of the Geography Department in the Maxwell School at Syracuse University. After receiving his PhD in Geography from Rutgers University in 1992, he taught at the University of Colorado before moving to Syracuse. PAMELA MOSS is Professor in the Faculty of Human and Social Development at the University of Victoria, British Columbia, Canada. She teaches in Studies in Policy and

Practice, an interdisciplinary graduate program aimed at producing critical interpretations and analyses of policies and practices. Recent publications include *Placing Autobiography in Geography* (Syracuse), *Feminist Geography in Practice* (Blackwell), and, with Isabel Dyck, *Women, Body, Illness* (Rowman & Littlefield). She is also active in local movements around women's housing, health, and invisible disabilities.

PAUL ROUTLEDGE is Reader in Human Geography in the Department of Geography and Geomatics at the University of Glasgow, Scotland. He teaches in Geographies of Resistance, Cultural Geography, Globalisation, and the Cultural Politics of Development in India. Recent publications include *Entanglements of Power: Geographies of Domination/Resistance* (Routledge; co-edited with Joanne Sharp, Chris Philo and Ronan Paddison). He is active in local autonomist initiatives and People's Global Action, an international network of grassroots social movements resisting, and constructing alternatives to, neoliberalism..

DAVID SIBLEY taught at the University of Hull until 2003. He is currently Visiting Fellow at the National Institute of Spatial and Regional Analysis, National University of Ireland, Maynooth. His principal research interests are in applications of psychoanalysis to spatial problems, the social production of knowledges, and the state's response to nomadic and semi-nomadic groups. ROB WILTON is Assistant Professor in the School of Geography and Geology at McMaster University in Hamilton, Ontario, Canada. His research focuses on the social geographies of disability. He is currently working on barriers to paid employment for people with disabilities, as well as the challenges psychiatric consumer/survivors face in accessing decent housing and adequate income.
